- The SNM requests one gratis copy of any publication that includes an SNM image.
- No image may be modified in any way without prior written permission from the SNM, including but not limited to: rotation, inversion, change of proportion, color alteration, superimposition, animation, cartooning, removal of blemishes or inscriptions, or in any other way.
- Use of a specific detail must be approved by the SNM in writing in advance and the caption must note that a detail has been used.
- Images of SNM objects and specimens must **not** be used to assert or imply that the SNM or the University of Oklahoma endorses any commercial product or enterprise, concurs with the opinions expressed in, or confirms the accuracy of any text used with these images.
- Authorization is given only by receipt of this counter-signed form after the form has been approved, an invoice sent to the requestor, and full payment received. Requests may take up to 2 months to process.
